RESOLUTION NO. 00-56

A RESOLUTION ESTABLISHING FEES TO BE CHARGED FOR  
LICENSES ISSUED UNDER CHAPTER 37 OF THE KALAMAZOO CITY CODE

Minutes of a regular meeting of the City Commission of the City held on the 15th  
day of May 2000, at 7 o'clock p.m., local time, at the City Hall.

ABSENT, Commissioners: None

WHEREAS, Section 37-12 of the Kalamazoo City Code provides that the City Commission may establish by resolution fees for vehicle for hire business licenses, vehicle licenses and license tags in such amount as to defray the reasonable costs of supervision, regulation and control of vehicles for hire within the City of Kalamazoo; and

WHEREAS, Section 37-74 of the Kalamazoo City Code provides that the City Commission may establish by resolution vehicle for hire driver's license fees in such amount as to defray the reasonable costs of investigation and issuance of vehicle for hire driver's license within the City of Kalamazoo;

NOW, THEREFORE, BE IT RESOLVED, that the license fees to be charged for the issuance of the above referenced licenses authorized by Chapter 37 of the Kalamazoo City Code are hereby set as follows:

1	Vehicle for hire business licenses issued before November 1st of any license year	\$50.00 per year
2.	Vehicle for hire business licenses issued after November 1st of any year	\$25.00 for the remainder of the license year
3.	Vehicle licenses or license tags issued before November 1st of any license year	\$50.00 per vehicle per year
4.	Vehicle licenses or license tags issued after November 1st of any license year	\$25.00 per vehicle for the remainder of the license year

5.	Vehicle for hire driver's licenses	\$20.00 per year \$25.00 if prior year's license not renewed by April 30
6.	Transfer of existing vehicle license or license tags	\$25.00
7.	Replacement of an existing license or license tag	\$10.00 per license
